MA MEET GUIDELINES

- ⇒ All aspects of the competition are required to be in compliance with USA Gymnastics Rules & Policies.
- ⇒ Host Organization, Meet Director and Competition Venue **MUST** be located in MA.
- ⇒ Each Host Organization and Meet Director, as listed on the sanction, may only have one competition designated as a qualifier on the MA Qualifying Calendar.
- ⇒ Open stretch will not be scheduled before 8:00am.
- ⇒ Last session will not be scheduled to end at 10:00pm.
- ⇒ Certified Medical Personnel (with a current USA Gymnastics Membership) must be stationed in a visible / dedicated location on site at all times.
- ⇒ Warmups will not overlap unless a separate area with gymnastics matting is available to accommodate all competitors.
- ⇒ Team awards are to be given at the end of each session.
- ⇒ Submit Request for Judges to appropriate personnel once the final MA Qualifying Schedule is released.
- ⇒ Contact the Meet Referee a minimum of 14 days prior to the competition.
- ⇒ Meet Directors using the Massachusetts Modified Format will adhere to the numbers of competitors per session as established by the USAG-MA State Administrative Committee.
